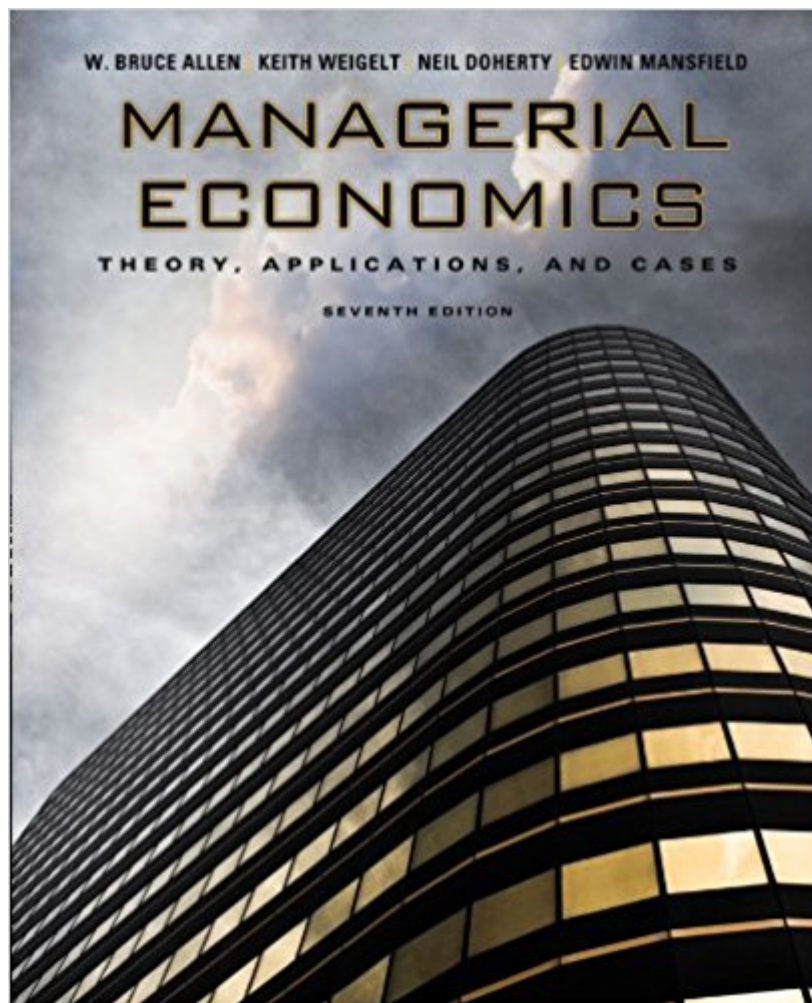

Chapter summaries would be useful, but that apparently wasn't considered when writing the textbook. So you are either stuck with your notes, or wading through pages of text for the axioms you need to remember. However this textbook is not as overly verbose as most modern textbooks and the organization of the e-book is very helpful.
