

The book was pretty basic and just like most nursing writing, it is very wordy when it may not be necessary. The section on delegation needs more relevance to practice, so instructors should not use it to teach the basics of delegation, maybe theory, but not practice. A separate resource is needed for that.

While going through the reading I found the information was bland, and it took quite some reading within the book to get the message and to the point. The case studies and boxes within each chapter were helpful. I knocked off one star due to the reading being a tad boring, but that can be expected for any textbook. The second star I had to take off was due to a large cut through the front cover of the book but then again it was rented. However for the price of the rental this student can't complain too much. Regardless, just be mindful if you are renting this book that there may be defects and some wear and tear.
