

Case Example:

**Blackmail** In an extortion case, the offender sent a message to the victim from a Web-based e-mail account. The Internet protocol (IP) address contained in the e-mail header showed that the message was sent from a computer located in an Internet cafe, but investigators were unable to determine who was using the computer at the time. Believing that the offender may have checked the Web-based e-mail account for responses to his message, investigators obtained all records relating to that account from the Internet service provider. These records indicated that the offender had indeed connected to the e-mail account from his home computer.
